Work experience at Coventry University London can be undertaken in a variety of ways depending on your chosen area of study. These options may include an internship, an individual or group consulting project or a simulation.

As an alternative to these options, you can choose to develop a business plan (Entrepreneurship Project) or opt to undertake a dissertation.

Get ready to progress to the second year of a degree in Business, Hospitality and Tourism, or Finance and Accounting.

The International Year One is an intensive, three-term programme, which is equivalent to the first year of an undergraduate degree.

In your lectures, workshops and meetings with guest speakers you will acquire basic financial and management accounting skills. You will also learn about profitability in production and investment appraisal techniques, as well as the role of stakeholders, organisations and organisational behaviour models and their use.

You will examine basic concepts of economic theory and their practical applications, the principles of marketing, market research techniques and how consumer behaviour impacts marketing strategies. You will also explore how ethics, innovation, globalisation and economic and social trends affect the business environment.




